A note on Racial/Ethnic Categories: Race is a social construct and a biological construct, neither of which are discussed in depth in this analysis. Thus, we use a simplified view of race to portray racial data to a broader audience. Ethnicity is also treated lightly, and while Latino is an ethnicity, it is generally treated and spoken about as a race, even though Latinos can be of any race. Additionally, each data source uses slightly different terminology and categorization. Considering all these factors, we use one simplified set of terms for the Race Counts website and publications for consistency while maintaining fidelity to the data sources as much as possible. However, the Racial/Ethnic Categories: described in this document come directly from the data source.

Economic Opportunity

Employment

Indicator: Employment to Population Rate (%)

Persons Employed as a percentage of total population age 16 to 64. This category includes all civilians 16 years old and over who either (1) were “at work,” that is, those who did any work at all during the reference week as paid employees, worked in their own business or profession, worked on their own farm, or worked 15 hours or more as unpaid workers on a family farm or in a family business; or (2) were “with a job but not at work,” that is, those who did not work during the reference week but had jobs or businesses from which they were temporarily absent due to illness, bad weather, industrial dispute, vacation, or other personal reasons. Excluded from the employed are people whose only activity consisted of work around the house or unpaid volunteer work for religious, charitable, and similar organizations; also excluded are all institutionalized people and people on active duty in the United States Armed Forces.

Values with low reliability were excluded based on the coefficient of variation. In addition, populations below 150 were screened out to remove outlier impacts. Index of Disparity calculated using the best (highest) rate.

Per Capita Income

Indicator: Per Capita Income (\$)

Income in the past twelve months per person, regardless of age or employment status. Values with low reliability, defined as a coefficient of variation greater than or equal to 30, were excluded.

Median Household Income

Indicator: Median Household Income (\$)

Median value of income of the householder and all other individuals 15 years old and over in the past 12 months. The median divides the income distribution into two equal parts: one-half of the cases falling below the median income and one-half above the median. For households and families, the median income is based on the distribution of the total number of households and families including those with no income. Median income is rounded to the nearest whole dollar.

Values with low reliability were excluded based on the coefficient of variation. In addition, populations below 25 were screened out to remove outlier impacts. Index of Disparity calculated using the best (highest) rate.

Poverty

Indicator: Individuals below Poverty (%)

To determine a person's poverty status in the last 12 months, one compares the person's total family income in the last 12 months with the poverty threshold appropriate for that person's family size and composition. If the total income of that person's family is less than the threshold appropriate for that family, then the person is considered "below the poverty level," together with every member of his or her family. If a person is not living with anyone related by birth, marriage, or adoption, then the person's own income is compared with his or her poverty threshold. The total number of people below the poverty level is the sum of people in families and the number of unrelated individuals with incomes in the last 12 months below the poverty threshold.

Poverty status was determined for all people except institutionalized people, people in military group quarters, people in college dormitories, and unrelated individuals under 15 years old. These groups were excluded from the numerator and denominator when calculating poverty rates.

Values with low reliability were excluded based on the coefficient of variation. In addition, populations below 50 were screened out to remove outlier impacts. Index of Disparity calculated using the best (lowest), non-zero rate, because ID cannot be calculated based on a rate of zero.

Cost-of-Living Adjusted Poverty

Indicator: Households above Cost-of-Living Adjusted Poverty (%)

The real cost measure of poverty that accounts for local costs of living, including the costs of housing, food, health care, child care, transportation, and other basic needs. It is a more accurate measure of financial security than the Federal Poverty Level. For information on methodology, please visit:

Connected Youth

Indicator: Youth in School and/or Employed

Connected youth refers to the percentage of youth ages 16-24, who are currently in school and/or employed. Advancement Project California excluded data for groups with *less than 250 youth* and values with low reliability based on the coefficient of variation, one of the Census Bureau's statistical quality standard measures. Low reliability here refers to values with coefficients of variation over 40% per <https://www.esri.com/library/whitepapers/pdfs/the-american-community-survey.pdf>. In addition, Advancement Project California excluded data for counties that do not contain at least one whole PUMA.

Indicator: Low-Income Adults in Food Secure Households

Percentage of adults in households earning less than 200% of the federal poverty level who are able to afford food (food secure). Respondents were asked various questions related to food security.

Corresponding source variables: POVLLAM1, AM2, AM3, AM3A, AM4, AM5. Advancement Project California excluded values where a CHIS 95% confidence interval denoted that an estimate was statistically unstable. Index of Disparity calculated using the best (highest) rate.

Business Ownership

Indicator: Business Owners per 1k Persons

Business ownership is defined as having 51 percent or more of the stock or equity in the business. Businesses could be tabulated in more than one racial group because the sole, majority, or majority combination of owner(s) was reported to be of more than one race. Firms with over \$1,000 in sales or receipts and with one or more paid employees were considered. Owners were calculated as a ratio of 1,000 persons of the same racial category.

Values with low reliability were excluded based on the coefficient of variation. In addition, populations below 10 were screened out to remove outlier impacts. Index of Disparity calculated using the best (highest) rate.

Indicator: Employment as Officials or Managers per 1k Persons

Officials and managers workers with the 2018 Standard Occupation Classification code of Manager (SOC = 11...). Advancement Project California excluded data for groups with *less than 450 people* and values with low reliability based on the coefficient of variation, one of the Census Bureau's statistical quality standard measures. Low reliability here refers to values with coefficients of variation over 40% per <https://www.esri.com/library/whitepapers/pdfs/the-american-community-survey.pdf>. In addition, Advancement Project California excluded data for counties that do not contain at least one whole PUMA.

Denied Mortgage Applications

Indicator: Denied Mortgage Applications (%)

Mortgage applications were for home purchases of one-to-four family dwellings that would be owner-occupied as a principal dwelling. The loan would be secured by a first lien. Mortgage applications that resulted in loan origination or denial by the financial institution were included. Applications that were withdrawn, approved but not accepted, or incomplete were excluded from this analysis. Groups with less than 15 applications were screened out to remove outlier impacts.

Values with low reliability were excluded based on the coefficient of variation. In addition, populations below 30 were screened out to remove outlier impacts. Index of Disparity calculated using the best (highest) rate.

Arrests for Status Offenses

Indicator: Status Offense Arrests per 10k Youth under 18

The average number of arrests for truancy over seven years was calculated for each racial group. An average rate was calculated using the average number of arrests for 10,000 youth under 18 of the same race.

Racial groups with less than 30 arrests in a county and with less than 100 youth in a county were excluded to remove outlier impacts by small population sizes. ID calculated using the best (lowest), non-zero rate, because ID cannot be calculated based on a rate of zero.

Indicator: Average Number of Civilians Involved in Law Enforcement Use of Force Incidents per 100,000 People by Race

Use of force incidents shown are those involving the discharge of a firearm, serious bodily injury, or death. Advancement Project California screened estimates where populations are less than 100 people. Estimates for Other and Multiracial populations not included because of mismatches in incident and population racial definitions. Index of Disparity calculated using the best (lowest), non-zero rate, because ID cannot be calculated based on a rate of zero.

Diversity of Police

Indicator: Police per 1k Persons of Same Race

We calculated the racial characteristics of police per 1,000 persons of the same racial group. The race of police officers and their supervisors come from the American Community Survey PUMS Estimates.

Advancement Project California screened out *populations below 450 persons* to minimize outlier impacts. We also excluded *values with low reliability* based on the coefficient of variation, one of the Census Bureau's statistical quality standard measures. Low reliability here refers to values with coefficients of variation over 40% per <https://www.esri.com/library/whitepapers/pdfs/the-american-community-survey.pdf>. In addition, Advancement Project California excluded data for counties that do not contain at least one whole PUMA.

Incarceration

Indicator: Adult Incarcerations per 1k Persons

The total institutional population in state prisons is identified based on the county in which the person was committed, not where they were arrested or live. We calculated the total number of adults incarcerated over five years and then expressed the rate per 1,000 persons in the county or state. The number of incarcerated adults shown is the total during the five-year period. Index of Disparity calculated using the best (lowest), non-zero rate, because ID cannot be calculated based on a rate of zero.

Indicator: Elected Officials of a Race per 100k Persons of that Race

Number of elected officials of a race per 100k constituents of that same race.

Advancement Project California selected elected officials at the state level holding office at the state and federal level for California, and at the county level holding office at the county level, and state legislatures whose territories overlap county borders.

We calculated rates of electeds' constituents by county by race using American Community Survey data. We screened out racial groups with populations of *less than 50 people of any one racial group* to make sure that a small number did not lead to general conclusions about a racial group in a county or across the state. Note: The data used for the city estimates differ from those used for the county estimates, making direct comparisons inadvisable.

We calculated rates of candidates' constituents by county by race using American Community Survey data. Index of Disparity calculated using the best (highest) rate.

Advancement Project California screened out racial groups with voting populations of *less than 30 people of any one racial group* to make sure that a small number did not lead to general conclusions about a racial group in a county or across the state. Index of Disparity calculated using the total average rate because only two racial/ethnic groups' data were available.

Percentage of registered voters voting in midterm elections. Data is only available for Asian, Latino, and overall populations. This indicator identifies races by surname, so instances where surnames cross racial/ethnic groups can be an issue; e.g., for Filipinos. Advancement Project California calculated an average of years 2002, 2006, 2010, and 2014 values.

Advancement Project California screened out racial groups with voting populations *of less than 30 people of any one racial group* to make sure that a small number did not lead to general conclusions about a racial group in a county or across the state. Index of Disparity calculated using the total average rate because only two racial/ethnic groups' data were available.

Percentage of registered voters among the total citizen voting population. Data is only available for Asian, Latino, and overall populations. This indicator identifies races by surname, so instances where surnames cross racial/ethnic groups can be an issue; e.g., for Filipinos.

Advancement Project California calculated an average of 2000-2014 (even years) values. Advancement Project California screened out racial groups with voting populations of *less than 30 people of any one racial group* to make sure that a small number did not lead to general conclusions about a racial group in a county or across the state. Index of Disparity calculated using the total average rate because only two racial/ethnic groups' data were available.

The percentage of households that filled out and mailed back their 2010 Census questionnaire.

Advancement Project California used the weighted average method to apply racial average values to this indicator. This method combines and aggregates indicator values with no race and population by race from a lower geography to the county and state levels to derive an average exposure by race value.

We screened out racial groups with populations of *ten or fewer people* to make sure that a small number did not lead to general conclusions about a racial group in a county or across the state. Index of Disparity calculated using the best (highest) rate.

The number of years a baby born can be expected to live if it experienced current age-specific mortality rates throughout its life.

Advancement Project California excluded values with low reliability based on the coefficient of variation, one of the Census Bureau's statistical quality standard measures, and outlier values based on small populations.

Index of Disparity calculated using the best (longest) life expectancy.

Advancement Project California also excluded values with low reliability based on the coefficient of variation, one of the Census Bureau's statistical quality standard measures.
